

Visa Requirement For Official Duties To Indonesia



- **Purpose:** A person who participates in meetings, incentives, conventions and exhibitions or other similar activities as a speaker, lecturer, presenter or public figure without being bound by a contract with a guarantor in Indonesia
- **Target group:** Oral Presenter/ Guest Lecturer/ Visiting Lecturer (Speakers/Presenters)/ Organizer who act as guarantor and Students

VISA C10: Invited Event Participants

VISA C9: Short Course

- **Purpose:** A person who is attending a benchmarking activity, short course or short training program
- **Target group:** Staff and Student

- **Purpose:**
 - C22:** A person who conducts internship in an education institution, company, or other institution
 - C22A:** A person who conducts an internship in Indonesia to satisfy the academic requirements of an overseas education
 - C22B:** A person who conducts an internship in Indonesia to develop skill and talent at the company, office, or workplace

- **Target group:** Students

VISA C22/ C22A/ C22B: Internship/ Academic Internship/ Company Internship

VISA E29: Research Activities

- **Purpose:** A person who participates in a research project at a research institute in Indonesia
- **Target group:** Staff and Student

- **Purpose:** A person who participates in meetings, incentives, conventions, and exhibitions (MICE) or Trade Fair to market goods or services
- **Target group:** Business professionals and commercial participants

VISA C11: Exhibitor



- **Purpose:** A person who is a national of a visa exempt country/special entity who will be visiting Indonesia for:
 - Visiting certain places for the purpose of recreation, personal development, or studying the uniqueness of tourist attractions including but not limited to traveling by yacht, or attending as a participant in meetings, incentives, conventions, and exhibitions activities;
 - Discussion, negotiation, and/or signing of business agreements including but not limited to offices, factories, or places of production of goods;
 - Conduct field observations of offices, factories, places to produce goods, places to be invested, and or mining facilities; and
 - Medical related activities
- **Target group:** Staff and students (Foreign visitors from visa-exempt countries on short-term, non-working visits to Indonesia)
